The inter-se-merit for the candidates shall be calculated on the basis of marks of Physics, Biology and any one of the three subjects i.e. Chemistry/Biotech/Computer science. 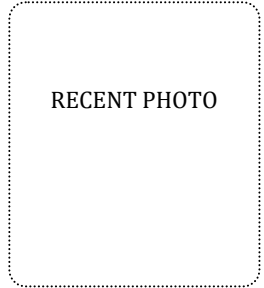
